(Unfortunately, the PCCRLTRO is unable to provide ongoing support for monthly bills or payments, gasoline purchases or personal business expenses.)

This PCCRLTRO support is not associated with case management. We will not ask you for personal financial information. Our only requirement is that you sign the form stating that you verify the information you have shared is true.

As a reminder, to be eligible for this assistance, you

1. Must be a resident of Pine City or Malden at the time of the fire
2. Must plan on staying or returning Pine Creek Community
3. Request for assistance must be **fire recovery related** (for example: building materials, replacement of items lost in the fire, support for fire-related mental health care, employment retraining). PCCRLTRO is unable to provide ongoing support for monthly bills, gasoline purchases or personal business expenses.
4. Must complete and sign the request form and return it to the PCCRLTRO as an email attachment, through the US mail at PO 47, Rosalia WA 99170, or in the drop box at Malden Town Hall.
